Mercy Manor is a ministry for women with histories of homelessness, abuse, mental health, incarceration, and alcohol and drug addiction.

Recovery peer support, assistance with obtaining alcohol and drug addiction services and recovery assistance is provided at Mercy Manor. The safe, spiritual environment of Mercy Manor encourages residents to participate in therapy, achieve self-sufficiency and personal growth while they re-establish themselves into the local community. Since the program's inception in 1992, more than 300 women have been served, 67% of these women have established safe housing, remained clean and sober, and are employed or enrolled in a post-secondary institution or accredited training program. Mercy Manor is a local charitable, non-profit, 501 (c) (3) organization.
